CHARACTERISTICS

Zinc Pro is a ready-to-use one-component protective coating with a high content of 98% pure micronized zinc of very high strength. Suitable for professional touch-ups and treatments. Light and bright colour. Provides excellent protection against the oxidising action caused by atmospheric agents and sea salt. It also resists high temperatures ensuring a strong cathodic protection against rust and oxidation even in outdoor environments. It dries quickly and does not drip. Provides a film thickness of more than 20 µm.

Salt spray corrosion resistance test: over 150 hours.

FIELD OF USE

Suitable for treatments and touch-ups on surfaces and articles galvanized by electrolytic process or galvanic bath (hot dip galvanizing). Recommended for the protection of metalwork and ferrous surfaces or components. Also suitable for coating and protecting welds.

HOW TO USE

PREPARATION.

Apply on clean, rust-free surfaces.

APPLICATION.

Stir the product thoroughly before use. It can be applied either by brush or spray using an airbrush. After application, be sure to close the can tightly to preserve the integrity of the product.

PRECAUTIONS.

If a subsequent painting treatment is planned, wait 6-8 days before proceeding and apply exclusively by spraying. Always check the compatibility of the product to be applied in advance (analyse the technical data and manufacturer's instructions).

COVERAGE.

5-7 m²/L

SAFETY FOR THE OPERATOR AND THE ENVIRONMENT.

Apply in well-ventilated areas. During use, wear appropriate personal protective equipment (gloves, goggles, mask and suitable clothing). Avoid contact with eyes and skin. Do not inhale. Do not release into the environment. Store in tightly closed containers, out of reach of children. Dispose of packaging in designated recycling bins. Containers with product residues must be disposed of at hazardous or special waste collection points.

WAREHOUSING.
